

# Summer Program in France: Paris & Arcachon

## Course Fees & Financial Aid Information

### Course Fees:

The program cost will vary based on the credit option chosen. For both options, a \$200.00 nonrefundable deposit is due upon acceptance.

- [\\$200 non-refundable enrollment deposit](#) (DUE with application)
- The cost of the **six-credit program is \$8,000** and will be charged to U-Bills as follows: \$2,000 in May, and \$6,000 in June (less the \$200 deposit).
- The cost of the **four-credit program is \$6,000** and will be charged to U-Bills as follows: \$2,000 in May and \$4,000 in June (less the \$200 deposit).

**Once paid, program fees are non-refundable.**

### Financial Aid Information:

The following is the budget applicable for Summer 2024. Other than the program fee, the costs listed below are estimated. Students should present this budget to their respective financial aid office to arrange for adjustments to their financial aid package. The Summer Program in France itself does not offer financial aid.
